C. SHIPPING AND WAREHOUSING POLICY

- 1. All items are sold on a make and ship basis.
- 2. Should a customer find it necessary to delay a shipment beyond the acknowledged ship date, the bottles may be invoiced immediately to the customer with an expected pay date of 30 days from the invoice date. A warehousing charge of 4% of the sales price will be invoiced for each month or any portion that the bottles are held by Hub Plastics.
- 3. Two months is the maximum that Hub Plastics will hold the bottles for the customer. At the end of the two months the bottles will be shipped to the customer at the customer's expense.
- 4. A 20% restocking charge will apply to all returns for stock bottles. The freight will be paid by the customer. Marketing approval for returns is required. Credit will be issued upon acceptance by the plant. No special run or custom items can be returned.
- 5. Shipping hours: No trucks will be loaded after hours, NO EXCEPTIONS. Any customer pick-ups or deliveries require 24 hours prior notification.
- 6. Customer arranged freight: Hub reserves the right to refuse loading freight without proper documention provided by driver at time of arrival. Drivers are required to have a PO#, Name of the Consignee, and the City and State of the Consignee in order to be loaded.
- 7. Any Bills Of Lading not generated by Hub Plastics must be received by 5:00 p.m. the previous business day. Bills of Lading sent the same day are not gauranteed to ship.

D. OVER AND UNDER SHIPMENTS

1. Hub reserves the right to ship on any order $\pm 10\%$ and consider the order complete.

E. MISCELLANEOUS GENERAL POLICIES & PRICING

- 1. Specialty packs will be quoted on request.
- 2. All prices shown are based on natural color only, unless otherwise noted for Geneva items.
- 3. Special colors other than black or white are quoted on request.
- 4. Stretch-sleeve labeling can be done on-line, for some bottles, for an additional cost of \$50.00/M Net. Contact the Sales Team for more information.
- 5. Less than a three day run can be produced by paying a \$450.00 small order charge. For a window stripe the charge is \$550.00. Any run that is less than one day requires special pricing.
- 6. A color purge charge of \$350.00 will be invoiced on all items, other than natural, if ordered in less than three day run quantities.

F. PROPRIETARY TOOLING

1. Contact Hub Plastics for information on customer supplied molds or custom built molds.

G. ACCEPTANCE OR REJECTION OF PRODUCT

- 1. It is the sole responsibility of the end user to determine suitability of our products for the purpose intended.
- 2. Notice of rejection must be received by Hub Plastics in writing within 10 days of delivery of such product.
- 3. Any products kept over 10 days will be deemed to have been accepted and return will be disallowed.
- 4. If a secondary operation, such as screen printing, is performed on any product after receipt by the customer, no return of goods so altered will be allowed. Goods so altered will be considered accepted as received and all invoices covering such goods will be due and payable under the standard terms in effect at the time.
- 5. Hub retains as its option, the right to have any rejected goods returned, scrapped by the customer, or inspected on the customer's premises by Hub Plastics Q.C personnel.

H. DISTRIBUTOR TERMS

1. Pricing is Net; based on a three day run. For a 5 day run deduct 2½% discount (Applies to Blacklick items only. Call for Geneva items).
